## Declaration: Down with the Pardon of the Genocidal Fujimori!\*

Peru People's Movement (Reorganization Committee)

The fascist, genocidal, and traitorous government of P.P. Kuczynski-Fujimori has fulfilled the orders of imperialism and reactionary forces by pardoning the criminal Fujimori. This pardon was expected from the very moment the extradition process of this genocidal criminal from Chile began, and all the presidents of the old genocidal State, from García to the current one, always announced it, preparing public opinion and the opportune moment. This has been accomplished, as reported in a reactionary newspaper, through "a farce. The farce was staged to save **Kuczynski**, to pardon Fujimori."

The pardon for the fascist, genocidal, and traitorous Fujimori was already announced in June 2017 by Kuczynski, who stated that "the time to pardon is now." The reaction and imperialism, colluding with revisionism, especially with the LOL and ROL (Left Opportunist Line and Right Opportunist Line) revisionist and capitulationist factions, have prepared this. All of them have fabricated a series of systematic lies against the leadership of Chairman Gonzalo and have unsuccessfully tried to discredit his name and his status as the most important revolutionary prisoner of war in the world.

The current authorities, both civilian and military, as well as those who preceded them, have tried to conceal their corrupt and shady system of deals within the higher echelons of the current government. In previous genocidal, fascist, and unpatriotic dictatorship governments, this system was linked to their campaigns of low-intensity warfare (GBI) as a complement to the yankee plan of "counter-subversive warfare." These deceitful tactics have been exposed, denounced, fought against, and will continue to be crushed

by the PCP (Communist Party of Peru) and the Peruvian people, with the backbone of the new Power of the Republic of New Democracy in Formation, the PLA (People's Liberation Army), being entirely directed by the PCP and always guided by the all-powerful and indestructible ideology of Marxism-Leninism-Maoism, Gonzalo Thought, firmly adhering to the Leadership of Chairman Gonzalo.

Chairman Gonzalo, despite being completely isolated and perpetually subjected to torture and imprisonment without any valid judgment or resolution, remains steadfast, combative, and defiant against the old system of oppression and exploitation by the old landlord-bureaucratic state in service of imperialism, primarily Yankee. Chairman Gonzalo demonstrates to the world his unwavering stance as a true communist and a great revolutionary, a firm and exemplary anti-revisionist fighter. For instance, in 2014, he denounced the system and the prosecutor, judges, and naval jailers in his late-night intervention from his cell, showing them how to do their job properly and once again crushing Movadef while disavowing their affiliation with the PCP, which was condemned by our Leader as belonging to such an organization and rejecting the accusations against him.<sup>1</sup>

The MPP (CR) [Peru People's Movement (Reorganization Committee)] has denounced, on the occasion of the so-called second round of the 2016 elections, that whoever was elected, in addition to serving the three reactionary tasks as part of them, had to grant "amnesty" to release the fascist, genocidal, and traitorous Fujimori and other civilian and military genocidaires from the golden jail. We stated that the matter under debate, amidst collusion and struggle between them, was how this would be carried out. We have also said that the government inaugurated on July 28, 2016, was the government of PPK and Fujimorism, due to the majority they had in congress and the specific task they had to fulfill as a necessity of the reaction for their counterrevolutionary war, known as "low intensity," against the Peruvian people and the people's war. When we refer to this fascism and these fascists, we are applying what is established by the PCP, which characterizes the regime established by the so-called "Fujimori self-coup" as a fascism suitable to combat the people's war. Today, it is clearer than ever that this is being fully implemented.

In our country, a broad movement of rejection against the pardon of the

genocidal individuals has been gaining momentum. It is clear to everyone that this pardon not only forgives the genocide against the masses, but also encompasses the intensified betrayal, the selling out of the country to the hammer, since the 1990s. Those who have benefited from the sale of the country are a few foreign and native exploiters, including among the latter, the representatives of successive governments from Fujimori to the present day. The genocidal Alan García, numbed and intoxicated by his own corruption, boldly stamped it with his statement: "Money comes on its own." There is no reactionary war without spoils. The pardon is an official forgiveness for genocides and the most shameless and base theft against the country. All of this further delegitimizes the old State and shows that it is corroded to the core, only able to be maintained through inertia and the force of arms. What is incumbent upon our hill is to continue its sweeping through further people's war, for which it is essential to strive more towards the culmination of the general reorganization of the PCP.

Teachers have mobilized, also family members, university students, and many other masses are mobilizing in rejection of such action by the government of PPK-Fujimorism. However, immunity to all their crimes and their impunity endorse them, which is a further discredit to their current fascist, genocidal, and traitorous dictatorship government.

The position of the PCP and its organism created for work abroad, the MPP(CR), is clear and forceful; it is to denounce the pardon for the fascist, genocidal, and traitorous Fujimori, as well as those that are in progress, for other civilian and military genocidal figures, as a necessity of the reactionary forces and imperialism, colluding with the new revisionism, to continue developing their so-called "low-intensity warfare," counterrevolutionary war, against the people's war. This forgiveness for all their genocides and other crimes is a condition to further their genocide against the Peruvian people and against their finest sons and daughters, the communists, fighters, and masses. Defending the Life and Health of Chairman Gonzalo through People's War! That is what we must do, that is what we must express in the face of this situation, not like Movadef, which operates within mobilizations to align itself with the struggle of 'human rights' organizations, the "left," etc., attempting to divert the masses down another path, the electoral path, seeking amnesty for the genocidal military personnel; in other words, mobilizing for amnesty and enlistment to transition into repressing the people alongside the reactionary forces. We condemn these wretched rats and those from the opportunist line with a rightist essence disguised as "left" or LOL, who do

not cease their attacks on our Great Leadership and Gonzalo Thought. Defend the Life and Health of Chairman Gonzalo with People's War!
