

WE DENOUNCE THE NEW

USING THE TRAITOROUS RATS OF THE
REVISIONIST AND CAPITULATIONIST

The new reactionary hoax aims to present the CPP to public opinion as divided: into a “continue [“Proseguir”–Trans.]” faction and another in favor of “real democracy.” In order to legalize the ROL as a “Maoist Communist Party” subject to order, incorporated into the old state as in Nepal and opposed to the people's war in Peru and in the world, this year's elections will serve them as a rehearsal for the reactionary objective of “amnesty for all,” the genocides beginning with García, Gampietri, Fujimori, etc. to serve to concretize the plan to assassinate Chairman Gonzalo. For the change of horses of reaction with the new government in 2011.

**1 This New Reactionary Hoax is Part of the
Plan of Greater Direct Intervention of Yan-
kee Imperialism Against the People's War**

The plan of the new reactionary hoax began to be implemented since the beginning of September of last year and is being developed through campaigns that will go up to the regional and municipal elections of next October, in

its first part; all in function of the major collusion and the “amnesty and enlistment” of the miserable rats of the revisionist and capitulationist ROL. The military component of this plan is developed with campaigns of encirclement and annihilation against the Support Bases and the new power, with greater genocide and more direct intervention of Yankee imperialism against the people’s war—through its “low intensity war” directed through the CIA and the support of its genocidal Zionist lackeys of Israel. Similar in that it pretends to “legitimize” with the defense of its “democracy” and the fight against “narco-terrorism.”

In this regard, we denounce: that the government of the genocidal Obama, through officials of his Embassy in Lima, has slipped to the Peruvian press (see Lima newspapers of the 9th of this month), that the Yankee government “offers up to 5 million dollars for information leading to the capture of the main leaders of the Shining Path,” which “is framed in the anti-narcotics reward program established by the US Congress in 1986.” And “how is the information for the reward going to be administered?” “According to well-informed sources in the National Police, the Police will serve to channel the information and informants, but the evaluation and the decision to grant or deny it, will be in the hands of the U.S. officials in Peru who direct the collaboration with the Police.” Thus, it is clear that the “agreements” of the “fight against drugs” is one of the bases of the direct intervention of Yankee imperialism against the people’s war in Peru. That under this pretext the CIA, using the cover of the DEA and the Yankee NAS, directs the Peruvian National Police. That in view of the inability of the Armed Forces and the Police to combat the people’s war, imperialism has the need to increase its presence with its own contingent and means, which it seeks to cover up and legitimize with this “rewards program.” With its hoax of “narco-terrorism” the government of the genocidal Obama tries to justify its intervention before the American people and the peoples of the world and seeks to isolate the people’s war of resistance against Yankee imperialism by showing it as “narco-terrorism.”

2 The Central Idea of the Reactionary Hoax is to Liquidate the People's War

The idea that guides imperialists, reactionaries and revisionists is to liquidate the people's war in Peru and wherever it develops and to prevent the beginning of those already in preparation. This is what unites them all. In their bourgeois conception they do not conceive of the exploited classes rebelling to oppose their system and they proclaim total submission, at most and to cover up their false democracy they allow discrepancies within the maintenance of the exploiting order.

In the world, the imperialist powers and superpowers, as they develop their inter-imperialist struggle as imperialist wars of aggression committing gigantic genocides against the oppressed countries; especially the U.S. imperialist superpower as the sole hegemonist, implements and promotes its "peace agreements" and participation in elections as in Afghanistan, Iraq, Palestine, Nepal, Peru and other places to end the armed resistance of the peoples and to prevent the main trend in the world: the revolution. So too, in India, the reactionary government following the U.S. plan has proposed "talks" to cover up its biggest genocide and seek to divide the revolutionary camp. While agitating in the press for "talks" it is developing further genocide as shown by the assassination of Comrade Assad at the hands of his reactionary captors. The imperialist plan seeks to divert the development of the new great wave of the world proletarian revolution seeking that it is not Maoism that leads it with people's war.

3 This Reactionary Hoax is linked to the October Elections this Year as a Dry Run for the 2011 General Elections

The reaction, with this hoax, is promoting the participation of the ROL rats in these regional and municipal elections, for which it is raising them using all the media at its disposal and the different forms of manipulation of public opinion of its psychological warfare as part of its "low intensity war."

The reaction under the direction of the CIA seeks in these elections to enthrone the capitulators of the ROL in the old state, through its "Movement for Amnesty and Fundamental Rights," thus seeking to "legalize" it; but

they propose that first they must ask for forgiveness, in the end it is that the capitulators publicly renounce revolutionary violence and thus present to the world the same as in Nepal. These elections will serve them as a rehearsal for what they will develop in the second part, which goes from after these elections until the general elections and the replacement of the government of the old landlord-bureaucratic State at the service of imperialism, mainly Yankee, since reaction needs new horses.

Naturally, this hoax is implemented in the midst of collusion and reactionary struggle, thus Julio Cotler, stated that these actions are part of Montesinism. As a revisionist, he knows that before these new revisionists, they would lose space. This is also the case in the reactionary media, while all are in agreement in raising the new hoax against the CPP, they show their discrepancies in its implementation and each one seeks to set their own conditions to gain their own advantage.

4 What the Reaction Seeks is Amnesty for All Genocidaires

What the reaction is looking for is amnesty for all, including the “Ethnocacerists” and genocidaires. That is why they are on the ROL’s list with the rat Walter Humala for the Region of Ayacucho, but of course, except for Chairman Gonzalo! This is how the new hoax is conceived (see ROL quote below).

See lawyer Carlos Rivera’s statement of the NGO Instituto de Defensa Legal (IDL) in “Quieren liquidar juicios sobre DD.HH” [“They want to liquidate human rights trials”–trans.] to the newspaper “La República” of Lima, July 10, 2010:

La República: “The delegation of powers has been formalized to legislate on the Code of Military Police Justice and the use of force, but also on rules for military personnel accused of human rights violations. What do you think?”

Carlos Rivera: “That the Executive is working on a sort of definitive, final solution for the cases of human rights violations, which seems to be the core of the matter. It was not part of the request for the delegation of powers and a sort of smuggling was organized to introduce the issue.”

La República: How do you plan to do it?

Carlos Rivera: The last campaign of Rey (Minister of Defense, our note) has not been an outburst, but an articulated campaign from the Executive to liquidate the cases of violation of human rights, since the end of the government is near. They probably want to establish legal mechanisms for the President and the Vice President of the Republic, who have a pending case for El Frontón, because although they have not included them, they fear that the action of justice may revert that situation. And finally, they aim at establishing significant improvements to achieve Alberto Fujimori's release'."

We know that these human rights NGOs are created by imperialism to serve its tactic of using both hands. Apparently imperialism, reaction and revisionism defend human rights in general, above classes; but in the end they only defend their right and freedom to subjugate peoples and nations with blood and fire; moreover, today, imperialism, mainly Yankee imperialism, uses human rights to impose norms that justify its intervention in any part of the world and to subject everyone to its hegemony. This same NGO, the IDL, to which this lawyer belongs, welcomed the "economic reinsertion" and the figures manipulated by Fujimori to show the decrease in "human rights violations" at the beginning of the 90s. In other words, he welcomed the total surrender to Yankee imperialism and its "low intensity war." But, we do not see them as a bloc, we must denounce them, differentiate them, see their contradictions, as in this case, to use them in the service of the revolution and denounce the genocidal policy of the counterrevolution. Even more so, in this case, which serves to denounce the plan of the reaction of amnesty for all the genocides, thus unmasking the service of the ROL to the CIA's plan.

5 The Amnesty's Purpose is to Give Shape to the Sinister Capitulation with "Leadership in a New Stage in Democracy."

The detention and absolute isolation of Chairman Gonzalo is entirely managed by the Yankee CIA and the Peruvian reaction. The policy of working with a part of the "dissident" prisoners (or Collaboration between the Nazis

in France and the countries occupied during World War II) = capitulators, is not new under the sun. That is why in the massacre of prisoners the reaction kills the consistent revolutionaries and protects the traitors.

In Ireland, in a massacre in October 1974 against the prisoners of the IRA,¹ British imperialism murdered the leaders who were about to continue the armed struggle and ensured that nothing happened to the traitor Gerry Adams, who would later become the head of Sinn Féin, who negotiated the “peace agreement,” the capitulation. In Peru, in the genocide against the prisoners of war of the Shining Trench of the Castro Castro prison in May 1992, the genocidal government of Fujimori-Montesinos assassinated more than 30 leaders of the CPP, but gave the express order to protect the rat Osmań Morote, who would later become one of the heads of the ROL-CIA.

Today, these new revisionist capitulators moved by their masters of the CIA and the fascist, genocidal, and fatherland-selling García-Gampietri government, serving the plan of imperialism say: “Facing 17 years of perfidious and illegal life imprisonment, as well as the absolute denial of his fundamental rights, with unalterable ideological conviction Chairman Gonzalo breaks once again the absolute and perpetual isolation of the Military Prison of the Callao Naval Base to reach the Party and the popular masses with his writings of legal strategy compiled by comrade Míriam in the book *De Puño y Letra* [“In Handwriting”–Trans.] (...) And, they go on, confessing where they aim with their praise of “Judas” to turn him into a “harmless icon” and serve the plan to assassinate him: “(...) The exemplary and touching communist attitude he shows in the defense strategy applied in the megatrial against him, **the absolute disinterest for his person focusing on the freedom of all political prisoners and prisoners of war in the country, the complete rejection with his total silence during the trial, stands out.**”

A confession of part is evidence, says the legal maxim that comes exactly to the case of what is written in the handwriting of these traitors: of course, on the one hand, they say “break the isolation” with the book written by Miriam; and, on the other hand, they celebrate the President’s silence. As we had already anticipated, in this quote, the service of the ROL rats to imperialism’s plan that we are denouncing - quoting an IDL lawyer at the service of Yankee imperialism (see above quote from IDL lawyer’s statement) - is very clear. According to the CIA’s plan, everyone goes out except Chairman

Gonzalo and so that he cannot denounce them, he does not speak! And, they make sure that he does not have the slightest chance; thus, as part of this new hoax they publicize a “marriage” of the Chairman with the rat Miriam, but they say that the authorities “have only authorized it to be done by proxy”; there are new oral trials against the President for cases that have not yet been the subject of another process, less of the so-called “Mega-trial”; but in the most scandalous legicide, the judges managed by the Marina=CIA, resolve that these are not to be carried out; because he has already been condemned in another process (see news in the Peruvian press of the 10th of this month). Everything so as not to present the President, everything so that he cannot pronounce himself. No matter how, no matter how much its own legal order is violated, removing a “defendant” from the action of justice itself. Thus, judges are made to prevaricate. This is a crime punishable by its criminal law. But, it does not matter, it is a matter of national security that the President remains isolated and cannot speak. And that is what the reaction has offered the rats of the ROL since 1993. Therefore, what should be done is to demand the public and direct presentation of the President so that he can make a statement.

6 We Denounce the CIA-ROL’s Ongoing Plan to Assassinate Chairman Gonzalo

What is in this ROL mammoth, which we have been denouncing, is that “Chairman Gonzalo fulfilled his role and that he will always be present,” etc. and that “now it corresponds to form a new fraction and leadership within this fourth stage.” It will be with Miriam or any other rat, that is the problem of the revisionists.

The objective is to have an amnesty, a “communist party” participating in elections; in the fourth stage, with a new leadership leading it, and then sooner or later they will tell us that the President committed suicide or some other version to cover up his assassination. See how the Chinese revisionists assassinated Comrade Jiang Qing. This they will do when they have politically exploited to the maximum the detention with absolute isolation of Chairman Gonzalo. The rats of the ROL say that the Chairman told them to participate in elections, but, in this respect, there is no document approved by their so-called “national leadership.” Thus, in this new reactionary hoax,

directed by the CIA with the help of the genocidal Zionists of Israel, the ROL has run amok in relation to its proposals up to 2005.

It is crystal clear that the plan to participate in elections is to enthrone capitulators in the old state, who are going to renounce revolutionary violence, with the new leadership they say they are going to have, in their fourth stage and serve so that the genocidal civilians and military are out scot-free. That is their gleeful sale to the devil. At the same time, they serve the replacement of authorities of the old genocidal State. And, in this way, they seek to annihilate the people's war in Peru and to traffic with it with the Communist Parties at the international level that are close to initiating a people's war. This is the great importance of continuing to develop the debate for the application of the fundamentals of Maoism, in which we are engaged in the ICM and, within it, the RIM.

Long live Chairman Gonzalo and his all-powerful thought!
